Thank you for choosing to fundraise for the UK Wild Otter Trust. Our small charity relies on kind people like yourself to raise vital funds.

In this pack you'll find information on how your fundraising helps, fundraising ideas and more.

We are a registered as a charity in the UK (Charity No: 1167746) and we are registered with the Fundraising Regulator.

We can collect Gift Aid on eligible donations, that's an extra 25% on top of donations and it doesn't cost a penny! Find out more on page 7.

How your fundraising helps

To rescue, rehabilitate and release back into the wild, one orphaned Eurasian otter cub, it costs us £3000. With around 30 otters coming through our doors every year, costs are high. We rely on donations, grants, and profits from our online shop & events. So, if you feel like you are able to help us continue our valuable work with this iconic species, we would really appreciate your support. UKWOT is fully run by volunteers so everything you raise will go straight to the otters.

HERE ARE SOME KEY COSTS TO HELP WITH YOUR FUNDRAISING GOAL:



Food for the otters is one of the highest costs for our small charity. It costs around £10 a day to feed one otter cub.

It costs around £30 to purchase milk powder that feeds small cubs for a month.



It costs around £50 to deploy our otter ambulance to an otter in need of rescue in Devon.







Fundraising Ideas

Individual

- Challenge yourself:

Donate the money you've raised

Gift Aid

If a donator is a UK tax payer we can collect 25% extra on top of your donation and it doesn't cost a penny!

Online platforms such as JustGiving will automatically ask if the donator is eligible to Gift Aid their donation.

If you are using our sponsorship sheet (can be found on the fundraising section of our website), there is a Gift Aid tick box and space for their address (we need their address to claim the Gift Aid). Completed sponsorship forms can be emailed to fundraising@ukwot.org.

Food Hygiene

Food hygiene laws apply whether food is for sale or not. Please ensure that you check out and follow the latest hygiene regulations at food.gov.uk.

Licenses

Ensure that you have the correct licenses for your event, e.g. selling alcohol or live entertainment. Contact your local council for more information.

Raffles/Lotteries

When running raffles and lotteries ensure to check out the latest regulations with the Gambling Commission gamblingcommission.gov.uk

Insurance

We, UK Wild Otter Trust, cannot accept any liability or provide any financial assistance for any fundraising or events.

Collections

It is illegal to carry out house-to-house collections without a license. Your local council will be able to provide for information.
